



### NATIONAL ANIMAL HEALTH FORUM





#### **PREAMBLE**

he maiden edition of the National Animal Health Forum took place at the Shehu Musa Yar'adua Foundation Center in Abuja on the 18th of January, 2024. The Honourable Minister of Agriculture and Food Security, represented by the Director of Planning and Policy Coordination, Dr Tanimu Ibrahim, delivered a keynote address that emphasized the need to build partnerships for improved animal health and livestock productivity to address food and nutrition security in Nigeria. The event, which boasted a total number of 181 industry stakeholders across Nigeria, hosted three department Directors and representatives from the Federal Ministry of Agriculture and Food Security, the leadership of two animal health FAO-funded projects, twelve State Directors of Veterinary Services, the Veterinary Council of Nigeria, the Nigerian Veterinary Medical Association, and private veterinary service providers. The organizing committee ensured the heterogeneity of stakeholders by inviting and ensuring the active participation of private livestock farmers and veterinary practitioners.

The forum encompasses six sessions, comprising goodwill messages from key industry stakeholders, a keynote address on building partnerships for improved animal health and livestock productivity, a presentation on the overview of the Nigerian animal health sector, a technical presentation on current trends in prevention and control of emerging and re-emerging animal disease, two-panel discussions and five breakout groups.

The six sessions clearly focused on striking discussions and developing recommendations and commitments that will

enhance partnerships for improved animal health and livestock productivity in Nigeria. The forum also allowed stakeholders to review the existing animal health policies and strategies, identify bottlenecks, and develop recommendations to improve the animal health sub-sector.

The summit has five specific objectives that directly address the theme of the forum. The following are the outcomes.

#### **OUTCOMES**

- The event facilitated meaningful discussions around the limitations to sustainable animal health care delivery at the last mile. Stakeholders from the public and private sectors, government agencies, development organizations, veterinary research institutions, and veterinary regulatory bodies participated actively and came up with the following recommendations and commitments.
  - The Department of Veterinary and Pest Control Services will work with animal health stakeholders to communicate and publicize the national animal health policies to increase public awareness and adoption.
  - The Department of Veterinary and Pest Control Services will finalize the development of a framework aimed at enhancing the delivery of veterinary services to the last mile through the provision of incentives, routine capacity development, logistics, and infrastructural development support to veterinary service providers and Community-based Animal Health Workers.

- National Veterinary Research Institute will work with the National Agricultural Development Fund and Propcom+ to build on the existing partnerships to scale the production and distribution of vaccines to smallholder farmers, especially those in the hard-to-reach community.
- The National Agricultural Development Fund will invite key animal health and livestock stakeholders to discuss the critical areas of investment and partnership.
- O Propcom+ will work with the private sector and development partners to replicate their vaccination model in other states. In addition, the Federal Ministry of Agriculture will increase its budgetary allocations for routine vaccination to institutionalize the process.
- o The National Veterinary Research Institute will partner with the Agricultural Development Fund to replicate the success of the mass production of the I-2 Newcastle disease vaccine across other vaccines to enhance livestock health and productivity.
- The Veterinary Council of Nigeria will collaborate with animal health stakeholders to amplify the impact and quality of service delivery of the Community-based Animal Health Workers.
- o Ambuvet Konsult will continue to work with

- development partners, government agencies, and other private sectors to train Community-based Animal Health Workers and deliver quality animal health services to the last mile.
- The forum also brought together industry stakeholders from development agencies implementing animal health-inclined projects, veterinary medical associations, the public sector, and government agencies to discuss bottlenecks limiting multisectoral achieve sustainable livestock partnerships to productivity. These stakeholders came up with brilliant recommendations and commitment to achieving this objective.
  - O NIRSAL will facilitate funding for interested livestock enterprises, including animal health service providers, by leveraging NIRSAL's existing business model and strategies.
- o Nigerian Veterinary Medical Association will identify and collaborate with animal health and husbandry professionals to introduce the one health approach to enhance the quality of animal health service delivery.
- NIRSAL will partner with the National Agricultural Development Fund to ensure funds are available for agriculture enterprises.





# IMPLEMENTATION OF THE EXISTING ANIMAL HEALTH POLICIES, THE CHALLENGES, RESOURCES REQUIRED, AND RECOMMENDATIONS



## Facilitator - Dr Shehu Shamshudeen - The Country Coordinator (Nigeria) Veterinary Paraprofessionals Project

This session assessed the level of implementation of the existing animal health policies, the bottlenecks limiting the successful implementation, and recommendations for a successful and sustainable implementation.

#### **Commitments**

- The Department of Veterinary and Pest Control Services will ensure the buy-in of critical political officeholders on the National Animal Health Policies and Strategies to facilitate funding and budgetary allocation.
- The Federal Ministry of Agriculture and Food Security to ensure sufficient and timely release of budgetary allocation for animal health services.
- To ensure continuity, the Federal Ministry of Agriculture and Food Security will partner with private sectors to institutionalize animal health services intervention.

- The Department of Veterinary and Pest Control Services will partner with private sectors and development agencies implementing livestock projects to develop appropriate communication strategies to cascade and educate all livestock stakeholders and the public about the content and implications of the National Animal Health policy.
- The Department of Veterinary and Pest Control Services will work with the State Department of Veterinary Services to establish a policy implementation and monitoring task force team to monitor, guide, and enforce the implementation and adoption of the animal health policies.
- The Department of Veterinary and Pest Control Services will partner with Sahel Consulting, Ambuvet Konsult, other animal health private sectors, Propcom+, and other development projects to track and catalogue livestock diseases, including transboundary diseases, to enhance national intervention and policy revision.
- The Department of Veterinary and Pest Control Services and the National Veterinary Research Institute partner with Propcom+ and the National Agricultural Development Fund to produce more vaccines and drugs to increase availability and accessibility.

STRENGTHENING COLLABORATION AND SYNERGY AMONG STAKEHOLDERS TO ENHANCE PARTNERSHIPS AND PROMOTE COORDINATED EFFORTS TO IMPROVE NIGERIA'S ANIMAL HEALTH AND PRODUCTIVITY

This session focused on the solutions to the bottlenecks limiting collaboration and synergy among livestock stakeholders and providing critical recommendations.

#### **Commitments**

- The Federal Ministry of Agriculture and Food Security will holistically map all livestock stakeholders along the value chain.
- Poultry Association of Nigeria, Miyetti Allah Cattle
  Breeders Association of Nigeria, and Pig Farmers
  Association of Nigeria to facilitate the formation of
  cooperative societies to facilitate collaboration and
  joint ventures.
- The Federal Ministry of Agriculture and Food Security
  will work with industry stakeholders to establish
  efficient communication and knowledge-sharing
  channels between ministries, departments and
  agencies, civil society organizations, non-government
  organizations, and private sectors.
- The Federal Ministry of Agriculture and Food Security will coordinate a bi-annual multisectoral livestock forum where livestock stakeholders can share ideas and explore partnership opportunities.

   annual convening to bring livestock stakeholders
   together to share the latest research advancements and
   innovations focused on enhancing animal health and
   livestock productivity.

• The Department of Veterinary Services to work with Sahel Consulting, Livestock247.com, Propcom+, Ambuvet Konsult, Zoetis, and other actors to develop technology that would aid the dissemination of new research findings and innovative ideas that can improve the animal health service delivery and livestock productivity.
